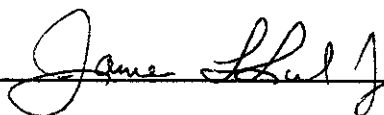

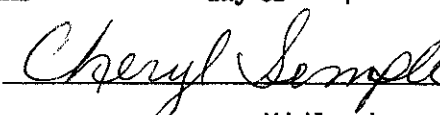

As per our telephone conversation, please find enclosed herewith the following checks paying the extension fee's for the following leases:

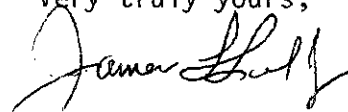

Please see our letter of April 6, 1982, concerning the 30 day extensions for the captioned leases. All of those leases expired on April 7, 1982, unless a valid application for a 30 day extension is made. At this time, we cannot consider these leases to be in effect as we have not received the necessary information requested in our letter of April 6, 1982. We have the rental payments, the affidavits informing us of the status of the drilling as of April 7, 1982, but, we do not have the letters of authorization from either J. M. Huber Corporation or Mesa Petroleum Company. Unless we have such letters of authorization by Monday, May 3, 1982, we must assume that the parties involved are not interested in retaining these leases and appropriate action will need to be taken.
