Dear Sir:

This is to advise you of our intention to plug and abandon our University "DO" Lease (14161) Well No. 1, University Block 9 (Wolfcamp) Field and (15108) Well No. 1-L, University Block 9 (Pennsylvanian) Field located 1981 feet from the west line and 660 feet from the north line of Section 4, Block 1, University Lands Survey, Andrews County, Texas.

Please remove well from proration schedule.

The following is our proposed procedure:

1. Casing Record - 13-3/8" Casing, depth set 1619 feet w/1300 sx.
cmt. circ.
9-5/8" Casing, depth set 4730 feet w/ 200 sx.
cmt. - Top of cement 3320 feet.
5-1/2" Casing, depth set 9568 feet w/ 460 sx.
cmt. - Top of cement 7400 feet.
2. Perforations - Pennsylvanian 9266 - 9336' - not continuous
previously abandoned.
8942 - 8974' - not continuous.
✓ 8870 - 8928' - not continuous.
✓ Wolfcamp - 8553 - 8580' - not continuous.
3. Abandoning Procedure -
 - a. Cap packer set at 8600 feet with 20 feet cement.
 - b. Set bridge plug at 8500 feet and cap with 20 feet cement.

- c. Cut and pull 5-1/2" casing from 7450 feet.
- d. Fill hole with 9.5# mud to 4780 feet.
- e. Spot a 100' cement plug from 4680 to 4780 feet.
- f. Fill hole with 9.5# mud.
- g. Spot a 10' cement plug at the surface.
- h. Weld steel plate across casing.
- i. Wellbore sketches attached for present and proposed conditions.

The anticipated plugging date is May 8, 1970. You will be notified in advance as to the time and date so that you may have a representative present to witness same.
