


DRIVING DIRECTIONS:


BEGINNING AT THE INTERSECTION OF TEXAS HIGHWAY 115/176 AND U.S. HIGHWAY 385, IN ANDREWS TEXAS. HEAD WEST ON TX 176 FOR APPROXIMATELY 4.5 MILES TO NW 2001 ON THE RIGHT. TURN RIGHT ON SAID NW 2001. GO NORTHWESTERLY FOR APPROXIMATELY 6.4 MILES TO FM 1967/ FRANKEL CITY HIGH WAY ON THE LEFT. TURN LEFT ON SAID FM 1967. GO WEST FOR APPROXIMATELY 4.1 MILES TO A LEASE ROAD ON THE RIGHT. TURN RIGHT ON SAID LEASE ROAD. GO NORTHWESTERLY FOR APPROXIMATELY 0.2 MILES TO A POINT IN SAID LEASE ROAD. THE STAKED LOCATION FLAG IS WEST APPROXIMATELY 73 FEET.
