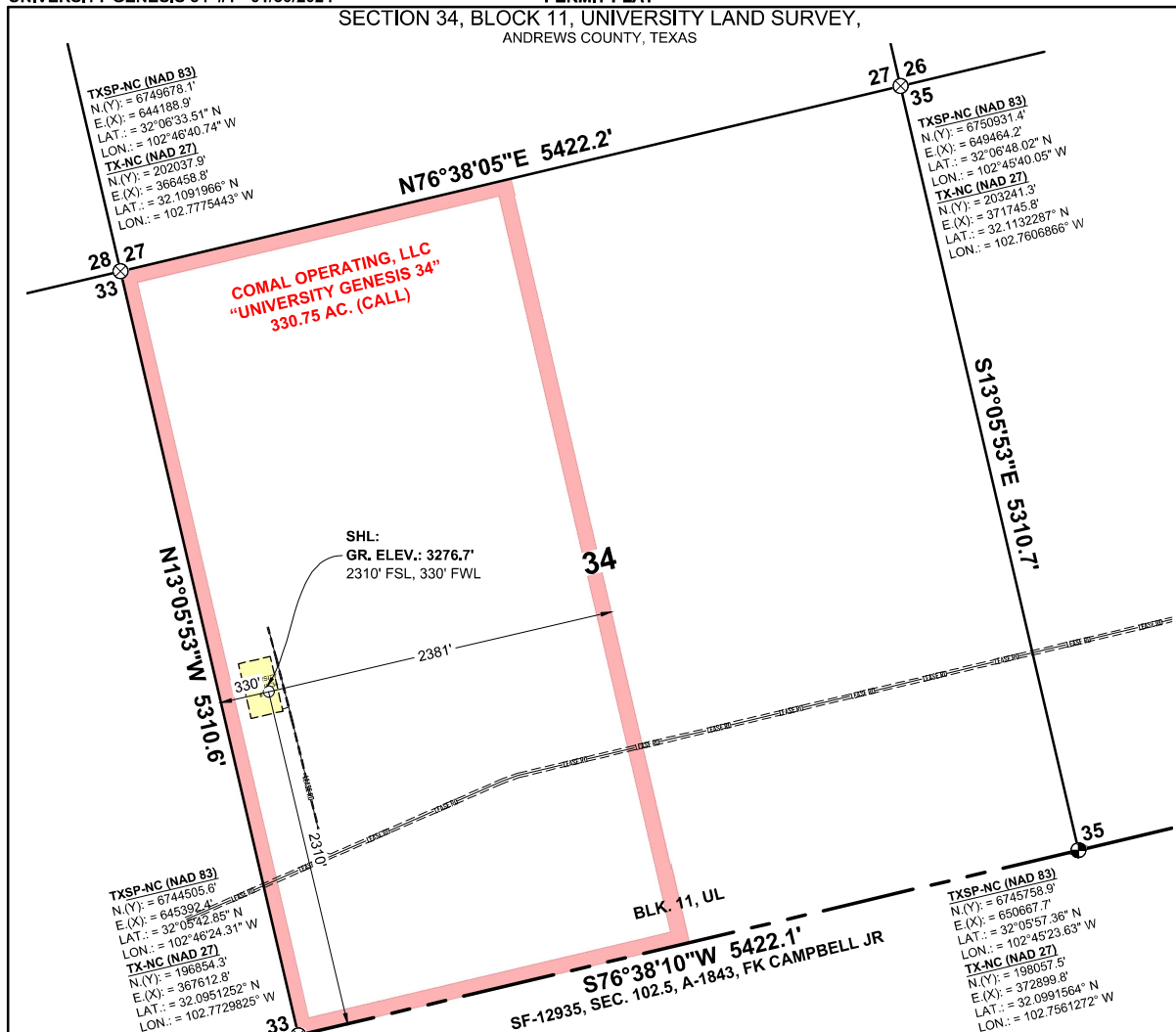
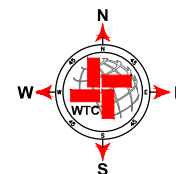


SECTION 34, BLOCK 11, UNIVERSITY LAND SURVEY,

## DRIVING DIRECTIONS:

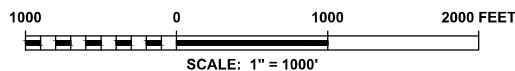
BEGINNING AT THE INTERSECTION OF TEXAS HIGHWAY 115/176/ BROADWAY AND U.S. HIGHWAY 385/MAIN STREET, IN ANDREWS TEXAS. HEAD WEST ON TX-HWY 115 FOR APPROXIMATELY 15.6 MILES TO FM 181 ON THE LEFT. TURN LEFT ON FM 181. GO SOUTH FOR APPROXIMATELY 5.4 MILES TO SW 7000 ON THE RIGHT. TURN RIGHT ON SW 7000. GO WEST 3.2 MILES TO A LEASE ROAD ON THE RIGHT. TURN RIGHT ON THE LEASE ROAD. GO NORTH FOR APPROXIMATELY 0.2 MILES TO A POINT IN SAID LEASE ROAD. THE STAKED LOCATION FLAG IS WEST APPROXIMATELY 97 FEET.
