Dear Operator:

Commission Staff has received a Form P-4 on the above referenced oil lease or gas well designating you as the new operator on Commission records. Commission records indicate that the above referenced oil lease or gas well includes one or more inactive wells that are not in Compliance with the inactive well requirements of Statewide Rule 15.

Under Texas statute as amended effective September 1, 2010, an operator who assumes responsibility for an existing inactive well must bring that well into compliance with the requirements of Statewide Rule 15 within six months of Commission approval of the transfer. Until such wells have been brought into compliance, the Commission may not approve a transfer of those wells to a subsequent operator.

Accordingly, you are hereby notified that you have six months following the approval of referenced Form P-4 to bring these wells into compliance with the requirements of Statewide Rule 15 by plugging, restoring to active operation as defined in Commission rules, or by securing a plugging extension.

FAILURE TO BRING THESE WELLS INTO COMPLIANCE WITHIN THE SIX-MONTH PERIOD MAY RESULT IN REVOCATION OF, OR THE INABILITY TO RENEW, YOUR ORGANIZATIONS FORM P-5 ORGANIZATION REPORT.
