According to Commission records the lease(s) on the attached list are subject to Railroad Commission Statewide Rule 36 (Oil, Gas, or Geothermal Resource Operation in Hydrogen Sulfide Areas). Statewide 36 is applicable to operations where the concentration of hydrogen sulfide in the system is 100 ppm or greater.

Statewide Rule 36(d)(M) states that "Certificates are nontransferable, and a new operator of a system or any acquired element of a system or operation shall be required to certificate that operation." To comply with this provision, you are required to file Form H-9 (Certificate of Compliance Statewide Rule 36) in accordance with SWR 36(d)(1) within 30 days of receipt of this notice.
